# PROOF OF RESIDENCY AND AGE REQUIREMENTS

The City of Coronado requires proof of Coronado residency in order to qualify for resident rates. The following are deemed sufficient for verification:

- Utility Bill
- Military Housing Orders (at least 6 months)
- Lease or rental agreement (at least 6 months)
- Property Tax statements
- Check with Address Imprinted
- Slip Rental (at least 6 months)
- Listed in the current Coronado phone book

Please provide a current copy of a valid government-issued picture ID to verify residency as well.

Proof of age is required for all people under the age of 18 to participate in programs. Proof of age is required prior to registration. The following are deemed sufficient for verification:

- Birth Certificate
- Passport
- Medical or Government issued ID card with birth date pre-imprinted
- Shot records with typed on birth date
- Faxed document from doctor's office verifying age
